BUMDes is a village economic institution where business capital is built on community initiative and adheres to the principle of independence. This means that the fulfillment of BUMDes business capital must be sourced from the community. However, it does not rule out the possibility that BUMDes can apply for capital loans from external parties, such as from the Village Government or other parties, even through third parties. This is in accordance with Law Number 23 of 2014 concerning Regional Government Article 213 paragraph 3). This explanation is very important for preparing the establishment of BUMDes, because the implications will be in contact with the regulations in Regional Regulations (Perda) and Village Regulations (Perdes). To support the improvement of the village economy, it is necessary to have a Village-Owned Enterprise (BUMDes) which can act as a forum for the village government and its residents to carry out proportional economic empowerment programs at the village level. The existence of BUMDes is expected to be able to stimulate and move the wheels of the village economy. A Village-Owned Enterprise (BUMDes) is a company managed by the village community and whose management is separate from the village government. BUMDes is defined as a business entity whose capital is wholly or largely owned by the Village through direct participation originating from village assets which are separated to manage assets, services and other businesses for the greatest welfare of the Village community.(Ridlwan, 2015).

One effort that can be made is optimizing the development of Village-Owned Enterprises (BUMDes) in order to move towards villages that are independent and creative in improving the welfare of the people in the region. Regulation of the Minister of Villages, Disadvantaged Regions and Transmigration Number 4 of 2015 concerning the Establishment, Management and Management, and Dissolution of Village-Owned Enterprises, which states that village governments can establish Village-Owned Enterprises (BUMDes). BUMDes is a business entity originating from village assets which is separated to manage assets, services and other businesses for the greatest welfare of village communities.

BUMDes are expected to be able to become a driving force for economic activities in the village which also functions as a social and commercial institution. BUMDes as a social institution supports the interests of the community through its contribution in providing social services, while as a commercial institution BUMDes aims to make profits to increase village income. The management of Village-Owned Enterprises is carried out by the Village Government together with the community(Karim et al., 2021). BUMDes management by directly involving the community is expected to be able to encourage the community's economy and improve community welfare. Every village that has formed a Village-Owned Enterprise is provided with funds from the government. Each village business that is run has its own advantages according to the needs and potential that exist in the villages.

RESEARCH METHOD

The method used in implementing this activity is descriptive analysis through the BUMDes Assistance workshop which has the potential to move the wheels of the village economy and be able to improve the welfare of community members. The method in this community service activity is active participation with the following activity stages:

- 1) *Workshops* with the topic of BUMDes development both in terms of finance, financing and the potential of BUMDes.
- 2) BUMDes screening activities from starting activities to selecting several selected BUMDes.
- 3) Assistance activities for selected BUMDes.

The initial establishment of PUSLITDESBANGDA was in 1989 under the name Rural Development Research Center (PUSLITBANGDES), in anticipation of globalization and regional autonomy which would bring about fundamental paradigm changes in government systems and mechanisms. In its development, in 2001 it changed to the Rural and Regional Development Research Center (PUSLITBANGDEKA), and then in 2006 it developed into the Rural and Regional Development Research Center (PUSLITDESBANGDA).
