Sulaimah et al (Supardi 2014:53) that the teaching profession is based on the following principles: (1) Having talent, interest, calling, and idealism; (2) Have a commitment to improve the quality of education, faith, piety, and noble character; (3) Have the necessary competence in accordance with the task field; (4) Obtain income, in accordance with work performance; (5) Having the opportunity to develop professionalism on an ongoing basis. Ernita (Surya, 2015: 209) said that in realizing proper teaching behavior, the expected characteristics of the teacher as a teacher, namely:

- 1. Have a great interest in the lessons and subjects they teach;
- 2. Having the ability to accurately predict personality and mood and make contact with groups appropriately.
- 3. Have the patience, familiarity, and sensitivity needed to foster a passion for learning.
- 4. Have imaginative (conceptual) and practical thoughts in an effort to provide explanations to students as learners.

- 5. Have adequate qualifications in the field, both content and methods.
- 6. Have an open, flexible, and experimental attitude in learning methods and techniques.

Related to the description above, it can be concluded that teachers must always improve their knowledge, teaching skills, attitudes, have broad insights, always improve their knowledge, not be oriented towards money and adulation from people, take many initiatives in accordance with advances in science and technology. The existence of a real example or example of a good teacher's personality will be the main foundation in providing the best education to students. the principal always accompanies, while providing motivation, as well as input to improve teacher performance

Furthermore, Daryanto (2015: 12) argues that children will be able to absorb knowledge well if they learn in a conducive classroom atmosphere. Managing classrooms that will be used in early childhood learning, of course, must consider children's needs such as the selection of materials, benefits or uses, size, color and shape, as well as a sense of security and comfort from the components in the classroom itself.

Maknunah (Budimansyah, et al 2013: 70) argues that active, creative, effective and fun learning (PAKEM) stands for active, creative, effective and fun learning. Active means that in the learning process the teacher must create an atmosphere in such a way that active students ask questions, express ideas, and look for the data and information they need to solve problems. A comfortable and safe atmosphere at school is an objective situation and condition at school that is perceived by students. a peaceful school atmosphere filled with comfort and safety both physically and psychologically.

Setiyadi (Kadarsih, et al 2016: 20) Says that learning activities in the classroom are supported by class climate factors. The quality of learning will be created if it is supported by a conducive classroom climate or atmosphere. Conversely, unfavorable class conditions will disrupt the learning process carried out in the classroom. At this point, the role of educators is very important in efforts to organize learning activities in the classroom. Therefore, it is necessary to strive to create conducive classroom conditions that support the results of the student learning process. Anjaswuri (Suchyadi & Karmila, (2019:14) argues that schools need to improve student learning outcomes by optimizing the classroom atmosphere or climate which is always conducive so as to facilitate teaching and learning activities.
