With unlimited information, especially learning resources that can be accessed by students and teachers through digital libraries, it will have an impact on learning activities where there are inhibiting factors that make it difficult to access this digital library based on the results. The interview that the researcher conducted through the response on behalf of Rivad Hajrumi said that there were some of us as students who did not have cellphones to access digital libraries and also the availability of a wifi network which sometimes experienced limited users when accessed by many people. The important role of digital libraries in improving the quality of students has been proven by (Hikamudin et al, 2019,) in his research which explains that there has been an increase in higher-order thinking skills (KBTT). for students whose graduation rate was only 42.5% to 87.5%. Purwanti, R 2017. In his research he also found a significant effect of the high category between digital libraries on increasing the level of student knowledge.

CONCLUSION

Based on the results of research regarding: Utilization of the Digital Library as a Learning Resource in Improving the Quality of Student Learning in West Seram 2 Public Middle School (Study there is West Seram 2 Public Middle School) it can be concluded as follows: The benefits obtained from the digital library as a learning resource in improving the quality of student learning at SMP Negeri 2 West Seram, namely: information facilities, recreation, as a source of teaching and learning activities in the school can help develop the quality of education or schools at SMA Negeri 2 West Seram.
