Based on data from the Committee for Handling Covid-19 and National Economic Recovery, on March 2, 2020, for the first time, a positive case of Covid-19 was detected and announced in Indonesia. Since then, positive cases of Covid-19 have continued to grow and develop, on November 15 2021 there were 4,250,855 positive cases of Covid-19 in Indonesia, of which around 4,098,178 people were declared cured, and 143,659 died. Based on this explanation, Covid-19 can be said to be a non-natural disaster that harms people's lives, and eliminates people's livelihoods, whether affected or not, besides that Covid-19 also disrupts the distribution and availability of community logistics. This is psychologically very disruptive to the condition of the community, and can even claim lives (Samudro & Madjid, 2020). Related to this, the government has also designated Covid-19 as a non-natural national disaster based on discussions on the national security of the Unitary State of the Republic of Indonesia which is stated in the provisions of Law Number 24 of 2007 concerning National Disaster (Huljannah et al, 2020).

#### **RESEARCH RESULTS AND DISCUSSION**

## Realization of State Defense Awareness as Agents of Change by Indonesian Young Generation

Defending the country is a form of love for the State of Indonesia. As citizens of Indonesia, defending the country is a right and obligation for all citizens as stated in the basic laws and regulations regarding defending the country. The 1945 Constitution Article 27 paragraph 3 states that "Every citizen has the right and obligation to participate in efforts to defend the state" and Article 30 paragraph 1 which states that "Every citizen has the right and obligation to participate in efforts to defend and secure the state". Law of the Republic of Indonesia Number 3 of 2002 concerning National Defense Article 9 paragraphs 1 and 2 which reads "Every citizen has the right and obligation to participate in efforts to defend the country which is manifested in the implementation of national defense". Implementation is also through:

- 1. Citizenship Education
- 2. Compulsory basic military training
- 3. Service as an Indonesian Army voluntarily or compulsorily



4. Service according to the profession.

Youth or the younger generation is a human resource that is expected to be the backbone of the Indonesian nation's defense. Through state defense education for youth, it is hoped that young people will have the basic skills of defending the country and have a sense of love for the homeland and the Indonesian people (Sancoyo, Y., Saragih, H. J. R., & Dohamid, A. G., 2018). The younger generation is an agent of change and an agent of control to be able to change the new order of the country. In this planting, the younger generation gets character education through the world of formal education which is arranged in such an integrated way through subjects both in the scope of kindergarten to tertiary institutions. Defending the country is the attitude and actions of citizens who are based on a sense of love for the motherland, awareness of nation and state, belief in Pancasila as the ideology of the nation and state, willingness to make sacrifices to face every threat, challenge, obstacle and disturbance both coming from within and from outside which is dangerous. survival of the nation and state, territorial integrity, and the noble values of Pancasila and the 1945 Constitution.

According to Sunarso (2008), what must be defended in state defense is that it contains 4 things, namely, independence and sovereignty of the state, national unity and integrity, territorial integrity and national jurisdiction, and the values of Pancasila and the 1945 Constitution. So from both understandings of defending the country, it can be concluded that defending the country is the behavior of citizens who are based on their love for the Indonesian State and can protect the country from various threats and problems. The purpose of defending the country itself is:

- 1. Maintaining the continuity of the life of the nation and state,
- 2. Maintaining the identity of the nation and state,
- 3. Carry out the values of Pancasila and the 1945 Constitution,
- 4. Preserving culture,
- 5. Doing good deeds for the nation and the State.

Paying attention, observing, and researching. Furthermore, if it is focused on its relation to youth as agents of change, especially for students of the Defense University of the Republic of Indonesia, according to the author, it is the nature of students as human beings and as Indonesian people who are cultured with their multicultural nature. Defending the State can be carried out and realized in the following ways:

- 1. Conduct research and development activities related to state and defense issues to provide solutions and views on the government as a policy maker.
- 2. Creating or establishing student organizations to exert influence or influence, especially on state defense activities in a positive and non-anarchic context.
- 3. Provide criticism through seminars and scientific activities both domestically and abroad for the implementation of mandates-laws and government policies to provide new perspectives and innovations to the national defense and security system.
- 4. Furthermore, this State Defense activity requires support from professionals, academics, and practitioners to provide views and mentoring on all youth activities. Because the young nation cannot walk alone without guidance and direction from experience and theories and practices in the field of state defense and security to carry out the awareness function of defending the country.

During the Covid-19 pandemic, based on many studies, it was seen that the morals and morals of society, especially the younger generation, were declining. Not only related to morals,

They prefer to skip classes/try to do activities that are enough to damage their character, namely trying things that smell of crime, such as stealing, violence against minors, and so on.

### Implementation of Health Protocols as a Form of Defending the Country

The Covid-19 outbreak has been designated as a non-natural national disaster that could threaten Indonesia's national resilience based on the provisions of Law Number 24 of 2007 concerning National Disasters. The concept of state defense follows the Law of the Republic of Indonesia Number 3 of 2002 concerning State Defense Article 6 paragraph (1), "State defense is carried out through efforts to build and develop capabilities, state, and nation strength, and to overcome any threats." In line with that, Article 9 paragraph (1) states that "Every citizen has the right and obligation to participate in state defense efforts which are realized in the implementation of state defense" which is further strengthened by paragraph (2), namely participation in state defense efforts in question is an effort to defend the country which can be realized through civic education, basic military training, compulsory military service or volunteering as the Indonesian National Armed Forces, and service according to their profession. Based on research conducted by Huljannah et al (2020), implementing health protocols to reduce the chain of transmission of the Covid-19 virus can be said to be an effort to defend the country in the context of the Covid-19 pandemic. Where the government makes regulations and the community implements them to create a sense of defending the country and national resilience.

In implementing the health protocol, the government is promoting campaigns related to the use of the hashtags #stay at home and #stay on masks. The participation of the younger generation in using these two hashtags and several other hashtags that support campaigns to maintain health by following health protocols can be said to have quite a positive impact. There is even cooperation between people as evidenced by the existence of education related to the urgency to stay at home during a pandemic. In several cases when there were influencers who were negligent in maintaining health protocols, the millennial generation dared to speak up. Whether through social media Instagram, Twitter, YouTube, or TikTok. This case was when Raffi Ahmad attended a party but did not use a mask after the first vaccine in Indonesia. In addition, a TikTok community by the account @botaktiktok2 does not use health protocols while on vacation in Bali. This is what eventually raises vigilance between people to look after and educate each other.

Based on research involving 65 millennials, it is known that 98.5% of them are aware of the obligation to defend the country amid the Covid-19 pandemic that has hit Indonesia. The table below shows the level of concern for the millennial generation as illustrated in the figure in the very indifferent to very concerned sections. The very concerned section shows a high level of concern and 50.8% of respondents show this result. This means that the majority of respondents are concerned about the current crisis conditions that Indonesia is currently experiencing (Wicahyanti et al., 2021).

In this case, the millennial generation as the generation that dominates Indonesia has an important role, especially in how to respond to concern for Covid-19 and increase the sense of the spirit of defending the country to protect the sovereignty of Mother Earth.

# Contribution of the Millennial Generation in Handling Covid-19 as a Form of Defending the Country

After discussing the role of the millennial generation in building the spirit of defending the country in the pandemic era, this time the author will explain what contribution the millennial generation can make in efforts to deal with Covid-19. Some of the contributions that can be made by the millennial generation are related to government policies regarding the Covid-19 health protocol as follows:

- 2. Activate the use of health protocol hashtags on social media.
- 3. Cooperation in caring for fellow citizens
- 4. Utilizing technology as an effort to increase public awareness
- 5. Building an online business to support MSMEs affected by Covid-19

It is known that the implementation of the health protocol during a pandemic can be categorized as a form of state defense that can be carried out by the Indonesian people during this pandemic, this is also supported by the words of the Governor of DKI Jakarta Anies Baswedan in an interview regarding PSBB on March 19, 2020 (tirto.id). Various forms of contribution by the millennial generation include participating in online fundraising events, material contributions in the form of money and necessities (given to small communities affected by Covid), and medical devices (given to medical personnel who are experiencing a PPE crisis), there are also volunteers in activities of spraying disinfectants in their living areas, and wearing masks when outside the home. The increasing demand for masks has been utilized by tailors to produce masks for sale to the public. However, several respondents showed their contribution by providing masks to people who have economic limitations, especially to stay healthy and meet the needs of masks for everyone.

Based on the results of analysis of library data and survey data by Pingky Anggelia, et al's research on 65 millennial generation children, it was stated that the results of the survey also proved that most of the millennial generation have realized the importance of defending the country amid during in a pandemic, although there are still a few who feel normal. Then the results of the study also showed that 81.1% of respondents had implemented social distancing in carrying out their activities (Wicahyanti et al., 2021). Positive results were also shown by the research of Saputro et al (2020) which showed that most people had implemented social distancing. In addition to implementing social distancing, people's attitudes are also positive in implementing other health protocols such as providing cleaning tools and carrying out activities from home (Saputro et al., 2020).

However, the results obtained still show that there is still a small proportion of people who do full-time work activities outside the home. As a fisherman, he is still active outside the home as usual. Furthermore, the survey also shows that the form of contribution of millennials as an effort to defend the country when a pandemic occurs is carried out in several ways, from the easiest way, namely staying at home, then becoming volunteers, and holding fundraising for communities affected by the pandemic, and so on. other. These results demonstrate positive behavior and awareness of defending the country for millennials in Indonesia during the pandemic. However, it is hoped that more in-depth research with a wider target population and respondents from other regions in Indonesia will show the accuracy of the results of this study.

### CONCLUSION
